## Part 1 Preliminary

### 1 Short title

This subordinate local law may be cited as *Animal Management (Amendment) Subordinate Local Law (No. 1) 2015*.

### 2 Commencement

- (1) Section 4 commences on the date 6 months after the date on which notice of the making of the subordinate local law is published in the gazette.
- (2) The remaining provisions commence on the date on which notice of the making of the subordinate local law is published in the gazette.

### 3 Subordinate local law amended

This subordinate local law amends *Subordinate Local Law No. 2 (Animal Management) 2012*.

## Part 2 Amendments to subordinate local law

### 4 Amendment of sch1 (Prohibition on keeping animals)

- (1) Schedule 1, from '(b) the keeping' to 'pre-existing local law;'—  
*omit*.
- (2) Schedule 1, paragraphs (c), (d) and (e) —  
*renumber* as paragraphs (b), (c) and (d).

### 5 Amendment of sch13 (Dictionary)

Schedule 13 —

insert—

**'domestic hen'** means a mature female domesticated chicken (*Gallus gallus*) which is older than 16 weeks of age.

**rooster** means a mature male domesticated chicken (*Gallus gallus*) which—

- (a) is older than 16 weeks of age; or
- (b) has commenced crowing.'

### 6 Minor and consequential amendments

Schedule 1 amends the subordinate local law.

### Section 6

1.      Schedule 1, item 14, second dot point, 'hen'—  
        *omit, insert—*  
        'domestic hen'.
  
2.      Schedule 1, item 14, third dot point and schedule 2, item 14, second dot point,  
        'hens'—  
        *omit, insert—*  
        'domestic hens'.
