I approve of Council returning my dog (if currently registered) to my property if found wandering for the first time. 3. I approve of Council releasing my details (if my dog is currently registered) to another person should they find my dog wandering, for the purposes of that person returning my dog to me. 4. I recognise that failure to comply with the Council's Local Laws and any relevant provisions of the <i>Animal Management (Cats and Dogs) Act 2008</i> may result in Council taking enforcement action against myself. 5. I have a proper enclosure to keep my dog in to prevent it from wandering or escaping from my land. 6. I acknowledge that my dog must be under effective control at all times if in a public place. 7. I will ensure that my dog wears the prescribed registration device (Registration Tag) at all times. Should the registration tag become lost or damaged, I must make an application to Council for a replacement registration tag. 8. I must not keep a Restricted Dog without a current Restricted Dog Permit.
