Proposals:	<ul> <li>Project title: Jet James Workshops Discussion:</li> <li>Sharon Gimbert spoke on the workshop/s proposal, as it was the Emerald Art Group Incorporated who was requested to contact Jet James on behalf on the local Central Highlands artists.</li> <li>The workshops include five-days of intensive printmaking works from start to finish. In addition to this will be a two-day weekend of painting workshop.</li> <li>Jet James has mentioned he will supply majority of the materials; the inks, the plates, etc.</li> <li>Jet James is hoping to be in the region around August 2020 for the Annual Art Awards and Arts around August.</li> <li>The aim is to attract 12-15 participants per day of each workshop.</li> <li>The flexibility of the workshops will be of great advantage. Participants can attend the 2-day workshops and if they enjoy them, they can sign up for the extra three days. 5	RADF Project amendment:	ACTION: RLO to advise Emerald Patchwork and Quilting Group of CHACAC's support to submit a RADF application.  CIP Videography workshops amendment The videography project was approved in RADF 2018-19 Round 3. Discussions below outline proposed changes to this project due to service provider changes.  Discussion:  There have been discussions prior to today's meeting about this previously approved application.  This is a split application that has been approved for a budget total of \$15000.  The major portion of \$10000 will be utilised as a variety of workshops for the community as per Media Training options document provided to CHACAC by International Media specialist, Lou Petho.  Other service providers were also previously considered for this project. CHACAC members have determined to support Lou Petho as a new artist living in the region.  Lou Petho has created a breakdown on the training he offers through media workshops including videography. This can cater for different audiences and a variety of skills development.  Members discussed that they will need to contact Lou Petho in order to provide him with formal direction surrounding the workshop options they wished to avail for the community.	
		<ul> <li>CHACAC members to decide on training options and RLO to progress discussions to formalise these workshops.</li> <li>There will be a minimum contribution fee to participate in the workshops, as noted in the RADF Guidelines.</li> <li>Members agreed with the heritage video section being held in the Central Highlands as a key workshop for recognising the history and heritage of the region.</li> <li>Discussions on the sections to suit which targeted audience:</li> </ul>	



- A heritage video and documentary workshop will benefit the community of the Central Highlands greatly as there is numerous persons with historic stories deserving a short film/videography presentation. This section targets almost anyone with interests in history and holding onto regional heritage.
- Promotional tourism will also target anyone and will at the same time promote the Central Highlands region, attracting visitors and newcomers to the community. Members will liaise with Paul Thompson from Central Highlands Development Corporation regarding this aspect.
- Emerald Little Theatre, other photography groups and youth are also target areas for consideration in workshop planning.
- o The fiction training proposal tabled will suit youth and theatre as well as other demographics in the region.
- Discussions were held about the length of the workshops and the flexibility of the days they are held. Requested to hold a two or three-day workshop on each selected media area, preferably over the weekend to cater for those who cannot attend on weekdays.
- ACO to contact Lou Petho and discuss workshop ideas, confirm timeline for initial workshop choice, direction on the proposed project outcome and to confirm day rates and requirements.
- CHRC can offer sessions over Skype at the Emerald council building if required.
- Members suggested to hold the workshops within in the next six months, or in May 2020. March and April are already busy months in the region with arts projects.

Outcome: Project workshop/s pending.

ACTION: RLO to organise a meeting with Lou Petho about the videography workshops and gather information to supply to the members.

Creative Connections; Carnarvon Creates

- The remaining \$5000 component of this CIP budget will go towards the Creative Connections project presented by Barbara Beazley.
- As discussed in the videography workshops grant, this is a split application and a more formal project outline has been submitted and approved to proceed.
